

4.	Name of tender	Supply, Installation, Testing & Commissioning of Fire Detection and Protection System for 10 storied multistoried commercial building, at 76 Motijheel C/A, Dhaka.
5.	Tender Method (One Stage Two Envelope).	The tenderer will submit detail technical offer with tender security in one sealed envelope and financial offer in another sealed envelope & both enclosed in one sealed envelope.
6.	Time for completion of delivery	As specified in the tender documents.

Eligibility of tenderers	Tenderer must have: (a) Experience of supply, installation, testing & commissioning of minimum 2(two) Fire Detection and Protection System each costing Tk 50.00 lac (minimum) for last eight years. (b) Authorization letter from the manufacturer/Importer/ Assembler to the tenderer to offer for supply of Fire Detection and protection System (c) Technical specification supported with original manufacturer's Catalogue/ Brochure. Without manufacturer's Catalogue/ Brochure, Technical Specification will not be accepted. (d) Valid Trade License, upto date income tax clearance certificate and VAT registration certificate. (e) Financial Solvency Certificate from any schedule bank of Bangladesh indicating credit limit from the tenderer's bank. Tenderers without having the required eligibility as stated above need not participate.
